# Six Bells Community Share Offer

#### INTERESTING STATS - IMPACT REPORT 2024 - PLUNKETT \*

The five-year survival rate for community businesses remains an outstanding 99% - more than double Office for National Statistics' data for small and medium-sized enterprises, which is 44% over the same period.


£2.9m in community shares was raised by 3,600 people in rural communities in 2023

As of the end of 2023 there were 787 community businesses trading across the UK - a mix of shops, pubs and other business types

Research by Plunkett partners Power to Change states that for every £1 spent with a community business, 56p stays in the local economy compared with 40p for large private sector businesses.

There is a growing opportunity to create employment and volunteering opportunities for local people – an estimated workforce of around 4,000 people bolstered by c.25,000 volunteers

Quite simply the community business movement is one with a network of dedicated people at its heart.

- £464,800 raised from 1,012 investors!
- Investors in the village and global!
- Investor enthusiasm supported successful award for Government match fund
- Established in Feb 2021, they bought the pub in August 2021!
